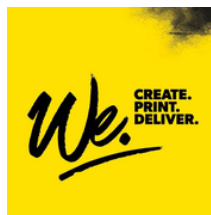

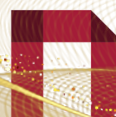

ABOUT THE AWARDS

The annual Department of Infrastructure, Planning and Logistics Awards for Excellence showcases the achievements and industry advancements of women, individuals and organisations in the Northern Territory construction industry. In 2022, the Awards for Excellence event welcomed 280 attendees, 52 award nominees, 27 award finalists, 10 judges and 9 award winners.

For the committee, the Awards for Excellence is part of a much bigger picture. As much as they are about celebrating individual achievement, they are also an important part of our mission to increase the broader visibility of women in construction by shining a spotlight on role models in our industry, opportunity for personal and industry networking, industry awareness, enhancement of skills and knowledge base and encouragement to pursue and establish careers in construction.

WHO CAN ENTER

Any person participating in the building and construction industry and who is a member of NAWIC, is eligible to submit an application to an award in respect of any of the award's categories. Applications may nominate an individual, a team or an organisation for the relevant award. Nominees must accept the terms and conditions listed during the nomination application process.

All nominees must be NAWIC members. You are welcome to submit an application for someone else, though their membership status will need to be confirmed before the application can proceed to the judging round.

Previous nominees and winners are eligible to enter - see Conditions of Entry.

In order to submit an entry, the nominee must be a current NAWIC member for the 2023/2024 financial year or by 5pm Friday, 04th May 2023 when entries to the NAWIC NT Awards close.

JUDGING

All entries are judged by a panel of high-profile industry experts, who are independent of both the NAWIC NT Chapter and Committee, and our partners. Hearing your stories inspires us at NAWIC, along with the rest of the industry - so we want to hear as many stories as possible. A streamlined nomination process makes it easier for you to nominate (and to nominate someone else).

The categories are broader:

Our intention is for this judging format - connecting contribution and impact - to open the Award categories to more roles across office, site or learning environments, levels of seniority, and project scales. We know construction is always a team effort - but we all make an individual contribution as well. We want to hear about yours (or someone else's).

It is easier to nominate someone else:

You don't need to know someone's entire career history to nominate them - you can simply tell us what you observed. Remember, they will have an opportunity to provide additional supporting information if they wish.

ABOUT THE AWARD

This award is the jewel in the crown of Awards for Excellence, this award recognises an individual or individuals, business or organisation who advances, furthers and promotes the advancement of women in construction, thereby making a significant contribution to the industry in the Northern Territory. Nominees should actively promote and encourage participation and career progression of women in the industry. Promotion may be by way of establishing policies, supporting legislation, and/or creating supportive organisational structures.

- Successfully breaking barriers with a "first" for women in construction

ABOUT THE AWARD

This award is not just about what was built, but HOW it was built. How you used ingenuity to achieve the final outcome, learning and innovation go hand in hand. If you are working in a construction related role and have found a way to do something better – then this award category is for you! Your contribution may be related to site safety outcomes, time, or cost factors, build quality, subcontractor management, and more.

Demonstrates an understanding of the client's priority with respect to time, quality and cost.

- Demonstrates the ability to understand and deliver the requirements of different project stakeholders
- Demonstrates understanding the value in developing and strengthening relationships consistently throughout the life of the project

SOCIAL RESPONSIBILITY AND DIVERSITY

ABOUT THE AWARD

Everything that we do (or construct!) has an impact on others. Being socially responsible is the process of considering how we can make the impact of our actions a positive one. This is an incredibly broad and important category that asks nominees to consider the impact that they – as individuals, a company or project – has, and demonstrate how it supports a greater good.

Has your team achieved an incredible outcome, found a creative solution to a problem, seen improved performance, or realised other tangible benefits through being diverse? Social responsibility can be shown in a variety of ways. It may be through stakeholder engagement, outreach, advocacy, volunteering or diversity, and inclusion. It may be the development of public facilities or supporting a community during the process of construction. It may be a commitment to your team's health and wellbeing. If you are an individual working within the construction industry who can demonstrate a significant commitment to other people – then we'd love for you to nominate for this award.

OPEN TO

This award is open to an individual or company working within the construction industry who can demonstrate a significant commitment to diversity, social responsibility, and people in the construction industry.

4. Provide an explanation of how the nominee went above and beyond their ordinary role requirements to champion social responsibility and diversity (500 words)

4. Provide two references to support this nomination

Supporting information (e.g., client testimonial or references) may be attached separately and in addition to the word limit.

THE JUDGING PROCESS

The NT Chapter Awards Committee will choose a judging panel to participate in the judging process, comprised of industry professionals who are independent of the NAWIC chapters and partners/sponsors. This group will consider the nominations and choose a winner in each category. The judges will be provided with all nominations prior to the specified judging evening for their review. At the judging evening, the judges will discuss each nomination and jointly choose a winner for each award. There will be at least one NAWIC Awards Committee member present at the judging evening and the role of that committee member will be to observe and provide additional information regarding the awards if required by the judges. The committee member will otherwise not participate in the judging process and will remain completely independent.

CONFLICTS

Judges will be asked to declare whether they know a nominee, in a professional capacity or otherwise. If yes, the NAWIC Awards Committee considers that this is a conflict of interest, the NAWIC Awards Committee may discretionarily elect to:

- Nominate a replacement judge for the whole judging process; or
- Ask the judge to sit out of judging the award in question.

It is foreseeable that our sponsors may have employees, clients or affiliates who have nominated themselves, or been nominated for an award.

NAWIC NT Chapter Council members are prohibited from being nominated for an award, but it may be the case that a NAWIC NT Chapter Council member has an employee, client or colleague that has been. The only NAWIC Chapter Council members who are (passively) involved in the judging process are the members of the Awards Committee. If a member of the Awards committee knows a nominee, that member will not take part in the judging process, even as an observer.

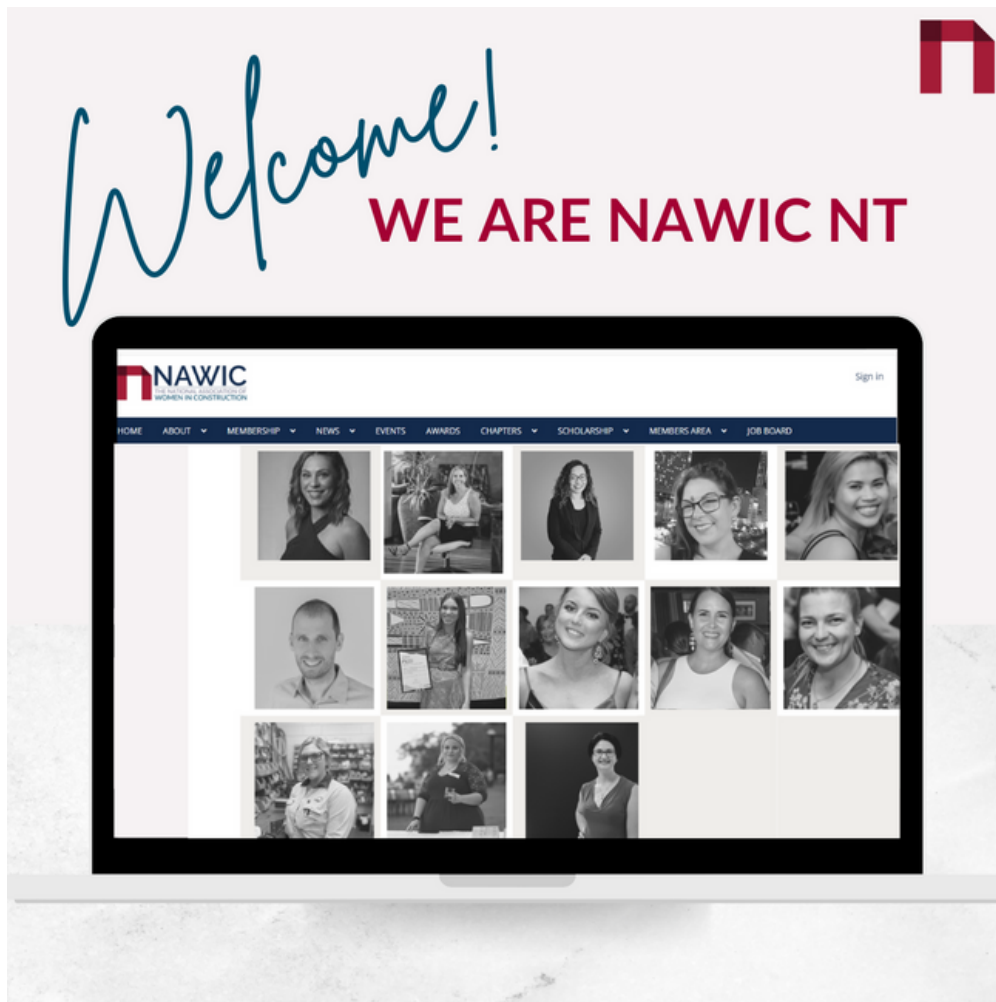


CONDITIONS OF ENTRY

- All nominations must comply with any rules stated on the online awards nomination webpage.
- Members of the NAWIC NT Chapter Council may not be nominated for an award.
- NAWIC NT Committee Members may be nominated for an award.
- Organisations nominated must have an operational unit in the Northern Territory.
- Previous NAWIC Award winners may submit entries for the 2023 Awards of Excellence; providing it is a different category and a previous winning entry cannot be resubmitted.
- The judges reserve the right to request further information and documentation from a nominee if required. The judges also reserve the right to determine the eligibility or otherwise of each nomination or consider a nomination which does not fulfil all the required criteria.
- The judges may consider a nominee for any other award regardless of whether the nomination has been prepared and submitted for that award.
- The judges' decision is final, and no correspondence will be entered into.
- Winning entries from past NAWIC awards may not be resubmitted, however previous entries that did not win may be resubmitted (provided that the nomination complies with the criteria listed in this booklet).
- NAWIC reserves the right to extend the final date of entry submissions, or, in its discretion, provide extensions to one or more potential nominees. NAWIC is under no obligation to provide an extension to all nominees or publish any extension.
- NAWIC reserves the right to use any nomination promotional or marketing material including photographs taken by NAWIC during the awards presentation breakfast.
- All submission material remains the property of NAWIC unless the nominee requests the return of the documents after the award presentations.
- A nominee may be nominated for more than one award; however, a separate online nomination must be submitted in respect of each award.
- Joint nominations of up to two women for each nomination are permitted, however both women need to satisfy the relevant criteria.
- Winners will be required to participate in post award publicity as notified by the NAWIC NT Chapter.
