



## NSW Awards for Excellence

### John Holland Award for Team Innovation

#### Award Description

<p>Purpose and Recognition</p>	<p>This award recognises team innovation and significant contribution to a successful development in New South Wales within the construction industry.</p> <p>This award recognises a group of women within a project team demonstrating their substantial contribution toward a successful project in New South Wales and the implementation of innovative work practices to areas such as construction, design and development.</p> <p>Innovation may involve (but is not limited to) capability development, occupational health and safety, work practices, change management, people management or learning and development.</p>
<p>Eligibility</p>	<p>Teams that comprise two or more women where a significant portion of the contribution is undertaken by women. Teams may comprise women from more than one organisation, provided that all member organisations operate wholly within the construction industry. Specialist training and human resources organisations are not eligible.</p> <p>The development and significant portion of team members must be located within New South Wales.</p>

#### How to Nominate

1. Register online and enter all details on the online entry page.
2. You must read and agree to be bound by the NAWIC Terms and Conditions of Nomination. NAWIC reserves the right to accept nominations in its absolute discretion.
3. Complete online submission, within the word count specified to address each assessment criteria below.
4. The online entry must include the following:
  - a. Nominee details entered online;
  - b. Nominee biography entered online;
  - c. Assessment criteria submission entered online;
  - d. Description of project entered online;
  - e. Letter of endorsement uploaded;
  - f. Letter of property / project owner consent uploaded;
  - g. Good quality image of nominee or nominee team uploaded (this image will be used in the Awards presentation event);
  - h. 5 images of project uploaded;
  - i. Consent of nominee team members to nomination.

## **Assessment Criteria**

Nominees will be assessed in accordance with the nominee team's ability to demonstrate the team's contribution to successful development and innovation, having regard to the significance of the relevant project, the team's work practices and application of best practice.

The nominee team must address the following assessment criteria:

1. Provide details of innovation applied by the team to the project.
2. Give at least two examples of a creative approach to opportunities and challenges for the project by the team.
3. Describe how the team implemented effective consultation and communication in the project.
4. Give an outline demonstrating how teamwork achieved a successful outcome.
5. Provide details of the contribution made by women within the team.
